Challenge

This busy healthcare system needed assistance to quickly create an up-to-date and accurate safety data sheet (SDS) document collection to comply with OSHA's HazCom requirements. In order to meet their goal of easy access to SDSs for all their employees and to ensure those employees were trained on SDS best practices, they first had to account for all the hazardous materials being used at their facilities.
